1. ALL display material is the responsibility of the exhibitor.
 2. Exhibitor assumes ALL responsibility for loss, theft, or damage.
 3. Exhibitor can unload and set up from 6:00 a.m. to 8:00 a.m. on Saturday, June 2, 2012. Exhibitor's vehicles must be out of the downtown area by 8:00 a.m. No exhibits may be removed before 4:00 p.m. on Saturday, June 2, 2012.
 4. Early Booth rental is \$50.00 per 10x10 space, if application is in by May 14th. We will take applications until May 21st, for \$65.00 per 10X10 space. This is an outside show. There is no guarantee for weather.
NO REFUNDS GIVEN NO EXCEPTIONS!
 5. Exhibitors will be responsible for all booth structures, set-up and furnishings.
 6. Any information given out must be given out within the confines of your 10x10 space
 7. Placement of booths will be at the discretion of the Committee.
 8. No recorded music will be allowed in booth areas.
 9. No exclusive rights for the sale of any item will be guaranteed.
 10. No participant will be allowed to set up without a signed/dated application and liability release.
 11. Your canceled check will be your confirmation of acceptance. **NO REFUNDS.**
 12. Committee reserves the right to determine whether goods are appropriate for the event.
 13. Further instructions will be mailed to all accepted applicants 1 week prior to show.
 14. No alcohol may be served.
 15. Exhibitors are responsible for tear down of their booth and cleaning of space before leaving.
 16. Oklahoma Tax Commission laws have changed so we will need a copy of your sales tax number. If you do not have a number you will be supplied with appropriate paper work to complete and return with your collected sales tax to the Main Street office before leaving the event at the end of the day. You will be sent the proper form before the event if you don't have sales tax number.
 17. No drinks may be sold or given away.
