- 2. You will NOT have access to electricity.
- 3. You will **NOT** have access to water.
- 4. You must provide at least 2 trash containers outside your trailer, and are responsible for dumping your trash at dumpsters!
- 5. Remember this is food-vending space only, and only food items will be sold. No non-food items will be allowed. —
 ** NO PASSING OUT OF FLYERS, PROMOTIONAL ITEMS OR FOOD OUTSIDE OF YOUR RENTED AREA!!**
- 6. Booth space is \$50.00 for food and \$35.00 for snack food trucks.
- 7. Set up is from 7:00 am to 8:00 am all vehicles must be out of downtown by 8:30 am.

There will be no set up after 8:30 am, and no refund for late arrivals. NO EXCEPTIONS.

- 8. You will not do any tear down until after 3:00 pm on Saturday, Satuday, July 8, 2023.
- 9. You will receive a map for space location approximately 1 week prior to event.
- 10. You **must** provide all the correct heath food cards and licensing with your paid entry form. This is your responsibility. The Health Department **will** be checking. All beer/wine vendors must prove copy of ABLE licenses.
- 11. Oklahoma Sales Tax number is required. We must have copy on file. It **MUST** be submitted with paid application. 12. There is no guarantee on weather as this is an outside show.
