- 5. We will take applications until June 26, 2023, for **\$35 for each 12 x12 space**. This is an outside show, there is no guarantee for weather. *Event is RAIN or SHINE! NO REFUNDS, NO EXCEPTIONS!*
- 6. Exhibitors will be responsible for all booth structures, set-up and furnishings.
- 7. Any information that is going to be passed out must be done within the confines of your booth space.

** NO PASSING OUT OF FLYERS, PROMOTIONAL ITEMS OR FOOD OUTSIDE OF YOUR RENTED AREA!!**

- 8. Placement of booths will be at the discretion of the Event Committee.
- 9. No recorded music will be allowed in booth areas.
- 10. No exclusive rights for the sale of any items will be guaranteed.
- 11. Further instructions and a map for space location will be provided approximately 1 week prior to the event.
- 12. No participant will be allowed to set up without a signed/dated application and liability release.
- 13. Your canceled check will be your confirmation of acceptance to the show. <u>NO REFUNDS.</u>
- 14. The Committee reserves the right to determine whether goods are appropriate for the event.
- 15. Exhibitors are responsible for tearing down their booth and cleaning of space before leaving. No exhibits will be removed before 3:00pm on Saturday, July 8 2023
- 16. Oklahoma Tax Commission laws have changed, so we will need a copy of your sales tax number. If you do not have a number, you will be supplied with the appropriate paperwork to complete and return with your collected sales tax to the Main Street office before leaving the event at the end of the day.
