Rules for vendors:

1. ALL display material is the responsibility of the exhibitor.
2. Exhibitor assumes ALL responsibility for loss, theft, or damage.
3. Exhibitor can unload and set up from 6:00 am to 8:00 am on Saturday, September 12th, 2026. Exhibitor's vehicle must be out of the downtown area by 8:00 am. No exhibits will be removed before 4:00 pm, Saturday, September 12th, 2026.
4. **Early Booth** rental is **\$66** per 12x12 space thru **July 28th 2026**. Applications will be accepted until **August 24th 2026**, for **\$86** per space. This is an outside show, there is no guarantee for weather. **NO REFUNDS, NO EXCEPTIONS!**
5. Exhibitor will be responsible for all booth structures, set-up and furnishings.
6. Any information that is going to be passed out must be done within the confines of your booth space. **** NO PASSING OUT OF FLYERS, PROMOTIONAL ITEMS, FOOD or DRINKS OUTSIDE OF YOUR RENTED AREA!!****
7. Placement of booths will be at the discretion of the Committee.
8. No recorded music will be allowed in booth areas.
9. No exclusive rights for the sale of any items will be guaranteed.
10. Further instructions and a map for space location will be provided approximately 1 week prior to event.
11. No participant will be allowed to set up without a signed/dated application and liability release.
12. Your cancelled check will be your confirmation of acceptance to the show. **NO REFUNDS**
13. The Committee reserves the right to determine whether goods are appropriate for the event.
14. Exhibitors are responsible for tear down of their booth and cleaning of space before leaving. No exhibits will be removed before 4:00 pm on Saturday, September 12th, 2026.
15. **Oklahoma Sales Tax number is required. We must have copy on file. It MUST be submitted with paid application.**
16. **You MUST have a business permit from the City of Sapulpa to participate.** Permits can be purchased prior to the event directly from City Hall located at 425 E. Dewey Avenue in Sapulpa. (918) 224-3040.
17. **NO ALCOHOL OR DRINKS WILL BE SOLD or PASSED OUT BY ANY VENDOR - NO EXCEPTIONS!**
