1. Non-Profit vendors must not sell any goods or services within their booth, this application is for groups/organization that are promoting their entity through handouts and promotional items ONLY.
2. ALL display material is the responsibility of the exhibitor. NO electricity will be provided.
3. Exhibitor assumes ALL responsibility for loss, theft, or damage.
4. Exhibitor can unload and set up from 6:00 a.m. to 8:00 a.m. on Saturday, June 1, 2019. Exhibitor's vehicles must be out of the downtown area by 8:00 a.m. No exhibits may be removed before 4:00 p.m. on Saturday, June 1, 2019.
5. Booth space is \$25 per each 12' X 12' space. This is an outside show, there are no guarantees on the weather and **NO REFUNDS, NO EXCEPTIONS!**
6. Exhibitors will be responsible for all booth structures, set-up and furnishings.
7. Any information given out must be given out within the confines of your 12'x12' space. **\*\* NO PASSING OUT OF FLYERS, PROMOTIONAL ITEMS OR FOOD OUTSIDE OF YOUR RENTED AREA!!\*\***
8. Placement of booths will be at the discretion of the Committee.
9. No recorded music will be allowed in booth areas.
10. No exclusive rights for the sale of any item will be guaranteed.
11. No participant will be allowed to set up without a signed/dated application and liability release.
12. Committee reserves the right to determine whether goods are appropriate for the event.
13. Further instructions and a map of your location will be mailed to all accepted applicants 1 week prior to show.
14. No alcohol may be served, and **no DRINKS of ANY kind will be handed out.**
15. Exhibitors are responsible for tear down of their booth and cleaning of space before leaving. No exhibits may be removed before 4:00 p.m. on Saturday, June 1, 2019.
